● About a Certified Administrative Procedures Legal Specialist (Gyoseishoshi)

A Gyoseishoshi is a national licensed lawyer who practices to prepare documents for public agencies and/or submit them on behalf of clients for fees in administrative applications and documents relating to rights and duties or certification of facts such as various contracts and wills etc. under Certified Administrative Procedures Legal Specialist (Gyoseishoshi) Act.

The demand for highly skilled legal and professional knowledge in documentary arrangement is growing with increasing complex and sophisticated social structure and business environment. Our legal specialist system has been widely recognized in Japan on the grounds that lawyers protect rights and interests of individual and society in addition to the efficient administrative procedures being ensured by their accurate and quick documentary preparation.

① What kinds of legal service does he/she provide in Immigration practice?

We take care of following procedures by filing applications to the regional Immigration Bureau on behalf of our clients.

- (1) Application for Certificate of Eligibility which is required for aliens in a foreign country wishing to be admitted to Japan, except for visiting Japan as a Temporary Visitor.
- (2) Application for Extension of Period of Stay.
- (3) Application for Change of Status
- (4) Application for Permanent Residence
- (5) Assistance in Application for Special Permission to Stay in Japan.

② What kind of international service does he/she provide other than Immigration practice?

We provide following legal services for aliens and companies.

- (1) Application for naturalization to acquire Japanese nationality
- (2) Consultation concerning international marriage, divorce, probate etc.
- (3) Proceedings and preparing legal documents for investment to Japan and establishing company etc.
- (4) Support to apply for notarization of documents for foreign countries and authentication of official seal or Apostille by Ministry of Foreign Affairs
- (5) Support to visa application for other countries

③ Major Services

We, as a specialist for the Administrative Law and the Procedures, may obtain required governmental permission, approval and license from relevant public office for the clients by providing our expertise and observing rules, regulations and laws of Construction Business, Transport Business, Entertainment Business, Pharmaceutical Business, Industrial Waste Disposal Business, Land Development Business, and other industries. We also prepare, as a representative, variety of legal documents for corporations or individuals and provide consultations for the said documents, which relates to rights and duties including Contract, Agreement on Distribution of Estate, Articles of Incorporation or Bylaws and Minutes of Meeting. We provide other professional services in the new field such as Adult Guardian System or Alternative Dispute Resolution.

● A Certified Administrative Procedures Legal Specialist (Gyoseishoshi) notified to Immigration Bureau

The practitioners specially trained for the Immigration Control and Refugee Recognition Act and the actual practice are termed Certified

Administrative Procedures Legal Specialist (Gyoseishoshi) notified to Immigration Bureau. They are allowed to file applications on behalf of their clients, and then clients are exempted from appearing to Immigration Bureau.

Business plan and company establishment

When a foreigner requests establishment of company, we give more careful consideration than when establishing a general company. We work with clients to create a business plan, starting from the drafting of the articles of incorporation, with a strong focus on applying for a status of residence and obtaining permits.



Application for residence status “Business Manager”

After establishing a company, we will check the immigration and residence status of the representative, and if the requirements are met, we will apply for a "Business Manager" status of residence. In order to receive a residence permission for "Business Manager", the representative needs to prepare and collect various documents that clarify the activities in Japan, and we will help with this application.



Relationship with the company after establishment

The Japan Federation of Certified Administrative Procedures Legal Specialists Associations and each prefecture's associations work together with financial institutions, so we also provide support in collecting and preparing documents related to financing. We also assist with company management in Japan from various angles, such as permit procedures and bookkeeping services, as needed



Application for renewal of “Business Manager” etc.

The status of residence has a period of stay, and renewal procedures are required to continue running a company in Japan. To apply for renewal procedures, it is necessary to clarify your financial and management status through financial statements, etc. We also assist those who support the representatives in entering and staying in Japan, such as by applying for "Dependent" status of residence in order to invite the representative's family.
